- 1. Chairperson
- 2. The Vice- Chairperson, who shall be of the opposite gender with the Chairperson
- 3. Secretary General
- 4. Finance Secretary
- 5. Academic Secretary
- 6. Games, Sports and Entertainment Secretary
- 7. Gender and Special Interest Secretary to be elected immediately after the results of the six (6) positions in SEC have been determined.

STUDENTS' REPRESENTATIVES FROM ELECTORAL COLLEGES.

- 1. 2 Representatives (Male and Female) from School of Education and Social Sciences
- 2. 1 Representative (Gender &Special Interest) from School of Education and Social Sciences
- 3. 2 Representatives (Male and Female) from School of Business and Economics
- 4. 1 Representative from School of Science
- 5. 1 Representative from School of Computing, Informatics and Technology
- 6. 1 Representative from School of Health Sciences
- 7. 1 Representative from School of Graduate Studies
- 8. 2 Representatives (Male and Female) for Halls of Residence
- 9. 2 Non- Resident Representatives (Male and Female) who must be non- resident All interested persons are requested to apply for these positions, thereafter collect nomination and clearance forms from the Office of the Dean of Students.

Duly filled nomination and clearance forms should be returned to the Office of Dean of Students not later than Friday 26th January, 2024 at 3:00 p.m.

Campaigns will start on Wednesday 7th February to Tuesday 13th February 2024 from 8:00 a.m. to 5:00 p.m.

QUALIFICATIONDS FOR ELECTION TO PARLIAMENT

One qualifies to be elected to parliament if at the date of nomination for election such a person:

- 1. Is a bona fide student of KAFU
- 2. Be having at least two full academic semesters remaining for completion of studies
- 3. Is registered in the Electoral College/ Parliament area the member seeks to represent.
- 4. Have a minimum average grade of 60% in the immediate previous academic year University exams.
- 5. A first (1st) Year student intending to contest should have an average of 60% of the available University academic results.
- 6. Not be a member of Students Electoral Commission
- 7. Have been cleared by the KAFUSA Electoral Commission
- 8. Not have been proven guilty in a disciplinary case in the University
- 9. Not have held position in SEC or Parliament for two terms in the University or any other University in Kenya.

NOTE:

- After nomination, candidates shall automatically be disqualified from elections if they
 incite other students to use violence, boycott lectures, and threaten or ridicule any member
 of staff or students.
- 2. Each candidate running for the position of Chairperson shall nominate a running mate of opposite gender and different ethnic background for the Office of Vice Chairperson
- 3. An election offence shall include: impersonation, Rigging, Violence, Intimidation, giving false information, campaigning on the polling day, any other offence that Electoral Commission may define as an act of commission or omission of any other rules governing the conduct of election.
- 4. Attach two (2) colored passport photo on your application form

Please cooperate in order to facilitate the smooth running and successful completion of the 1st KAFUSA election process.
